Each year the Atlanta Claims Association awards the Andrew B. Robertson Scholarship to a deserving student at the University of Georgia who is studying Insurance and Risk Management. To assist UGA in helping out deserving students, they received \$2000 from ACA. UGA awards two students \$1000 scholarships.

The first recipient is Scott Dykstra from Snellville, Ga. Scott is scheduled for graduation in December 2010, is expected to leave UGA with a Bachelor of Business Administration in Risk Management & Insurance. He not only received the ACA scholarship but is also a HOPE scholar with a GPA of 3.68.

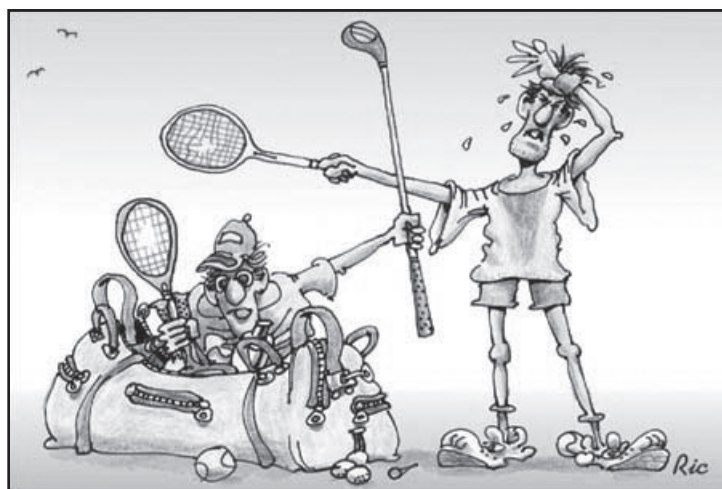
